

# Town of Nepeuskun

PROCEEDINGS OF THE REGULAR MONTHLY MEETING OF THE NEPEUSKUN TOWN BOARD HELD MONDAY, AUGUST 17, 2020.

The regular monthly meeting of the Town Board of the Town of Nepeuskun was called to order at 7:01pm at the Nepeuskun Town Hall, 1475 County Rd E., with all Board members and 4 citizens present for the meeting.

Clerk Pinnow certified that an official notice for this meeting had been posted at the official Town Hall posting site and the Town Website on August 14, 2020.

Motion was made by Supervisor Wargula and second by Supervisor Zache to approve the agenda for the August 17, 2020 meeting. Motion carried unanimously.

Motion was made by Supervisor Zache and second by Supervisor Wargula to approve the Consent Agenda for all agenda items including:

Motion carried unanimously.

Public Appearances:  
Randy Heise was in attendance inquiring about ATV/UTV routes and asking if it can be put on a future agenda for a decision.

Old Business:  
Discussion was held regarding status of property clean up at 625/627 County Road E. Pat Long from Pat's Moving and Hauling was in attendance virtually and provided information regarding his visit to the property. Motion was made by Supervisor Zache and second Supervisor Wargula by to authorize Pat's Moving and Hauling to complete the necessary work needed to comply with the Consent Decree. Motion carried unanimously. Chairman Grahn requested Mr. Long to complete a scope of work for the project and submit to him prior to beginning work.

New Business:  
10a. Motion was made by Supervisor Zache and second by Chairman Grahn to authorize the town to participate in the "Routes to Recovery" grant program. Town was awarded \$12,112, based on a per capita amount. Motion carried unanimously.

10b. Motion was made by Supervisor Wargula and second by Chairman Grahn to approve of bartender's licenses for Vines & Rushes Winery. Motion carried with 2 votes in favor and 1 vote opposed.

10c. Discussion was held regarding future newsletter topics. Articles are due to Treasurer Gravunder by September 18<sup>th</sup>.

11a. Rush Lake Project:

Ron Bahn provided update. Teleconference was held with Rush Lake watershed officers. Discussions are occurring with local DNR staff regarding future potential cattail burning. Ellen Barth will be retiring and replacement has not yet been named. Phase 1 of the Lake Management Plan will roll out in October. Cause of Mondays fundraising event to be held at Vines & Rushes Winery on October 19, 2020. Annual bog cleaning was completed on August 17, 2020.
